The performance prior to the above dates were achieved under previous manager and/or investment strategy.

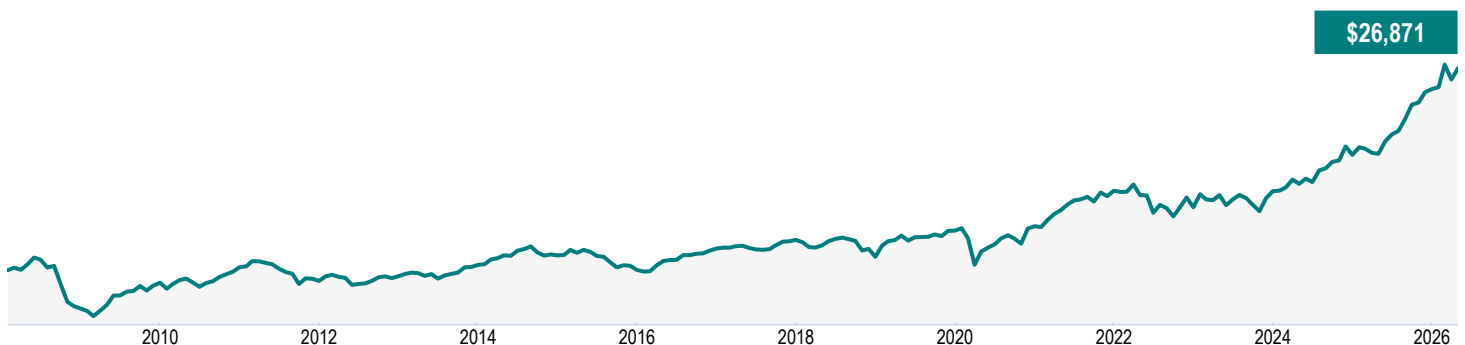
